## Course Description

Modals and conditionals are two types of expressions we use to talk about the non-actual and the unknown. This class is a survey of some classic and contemporary work on various aspects of both of them. We will focus on the semantics and pragmatics of modals and conditionals, however, we will touch on a number of other areas, especially in metaphysics and epistemology. Some questions about subjectivity and objectivity are raised by considerations of epistemic modals and indicative conditionals. We will discuss whether the treatment of these expressions requires modifying the basic framework used to theorize about meaning and language use.
